

Birmingham & Solihull Social Economy Consortium (BSSEC) Annual Report 2012-13 www.bssec.org.uk

From 2000 to 2011, BSSEC operated as an informal consortium, enabling key players with a shared interest in supporting and growing the social enterprise sector to work together effectively and increase the value and impact of what they do. During this time we established ourselves as an acknowledged centre of expertise on all things social enterprise.

BSSEC has been an acknowledged centre of expertise on all things social enterprise for nearly 13 years

In March 2012 we incorporated as a Community Interest Company and formally began trading in June 2012.

Choosing the CIC form has been a great success for us. Within months of incorporation we were able to raise almost £46,000 to help fund two major projects, including extending the email information and news service which goes out virtually every day to hundreds of subscribers.

The two primary funders of BSSEC's activities during the year have been the BIG Lottery Awards for All programme and the Barrow Cadbury Trust. The latter is funding a substantial programme of work to help us improve implementation and use of the new Public Services (Social Value) Act 2012 legislation, and over the past year we have worked closely with key partner Birmingham City Council to help it implement the new law, and with social enterprises to raise awareness and understanding of the Act.

Our work on social value is moving the debate on – from theorising about the concept to real, practical lessons about its use and implementation

This work is currently being followed by a variety of public bodies, MPs, academics, and other local councils. It is shifting the debate on social value from theorising about the concept to real, practical lessons about its successful use and implementation.

An overview of the year...

In the year in question we have:

- (a) Engaged in research, policy development and support to help a key local partner – Birmingham City Council – and local social enterprises better understand and implement new social value legislation (the Public Services (Social Value) Act 2012). You can access all of the briefing materials we have so far produced on social value on the dedicated policy page of our website.¹
- (b) Held a policy briefing event on social value for c.40 senior council officers/commissioners, produced briefing materials, supported Birmingham City Council's Head of Procurement & Strategy in developing social value guidance; and drafted a Social Value Policy for Birmingham City Council which was adopted by Cabinet on the 22nd April 2013.
- (c) Produced free briefing papers for social enterprises and third sector organisations on:
 - 'The Community Right to Challenge: A guide for social enterprises and the third sector'²
 - 'The Public Services (Social Value) Act 2012: A guide for social enterprises and third sector organisations'³
 - 'Social enterprise & public service reform: A guide for public sector workers, social enterprises and third sector'⁴
 - 'The Localism Act 2011: A guide for social enterprises and third sector organisations'⁵
- (d) Disseminated hundreds of emails on issues of relevance to the sector, including promoting numerous social enterprise events, successes and news. In fact, some organisations we have distributed information for have told us that they have filled – and sometimes over-filled – events as a result of our e-mailshots!
- (e) Posted over 110 items on our blog consisting of news, policy updates and other matters relevant to the sector.

Social enterprise & the LEPs

In addition, for almost two years now we have been working closely with the Greater Birmingham & Solihull Local Enterprise Partnership (GBSLEP) to try and ensure that social enterprise is firmly on the LEP's agenda.

This is important because the LEPs – which are private sector business-led bodies – are the successors to the old Regional Development Agencies, and while they don't have the financial budgets that the RDAs once had, they are responsible for all aspects of local economic development,

including, from June 2013, deciding how EU structural funds are spent locally. This makes it even more important that the LEPs acknowledge the economic and social role of both social enterprise and the wider third sector.

To this end we are currently developing a research method for a social enterprise survey across the GBSLEP territory which will help build-up the evidence-base regarding the sector's economic and social contribution.

Extending the audience for social enterprise

Thanks to the BIG Lottery *Awards for All* programme we have also successfully carried out a complete rebuild of our website, extended our news and information service and continued to build on the readership and profile of the BSSEC Blog.

It is a sign of how social enterprise is changing in Birmingham that just four or five years ago, when last we had major work done on our website, we had to accept tenders from as far away as Bradford in order to find a social enterprise provider able to undertake the work. This time, the tender was won by Citizen Coaching, a young social enterprise right here in Birmingham, which delivered not just great quality but unprecedented value for money.

Business support

Anyone who has tried to find and access free business support for social enterprise over the past couple of years will have learned how difficult this has become.

But in extremely difficult operating circumstances, individual BSSEC members have continued to secure funds that enable their continued delivery of support and development for the sector, including some support delivered in partnership. Our members will continue to work to maintain specialist business support which is free-at-the-point-of-delivery, and we are also working hard to try and ensure that the LEP's future investment priorities regarding business support include services that are appropriate to and reflect the values of social enterprise.

Raising awareness & understanding

Despite social enterprise being yet again at the forefront of many aspects of government policy – in public service 'reform', the setting-up of public service 'mutuals', and in new legislation like the Localism Act that offers new powers to local communities – we still find that public understanding of social enterprise (and that of politicians and policy-makers!) is not what one might hope.

In the coming year, then we will continue to prioritise research, information production and general educational efforts to support the social enterprise sector and help aid public understanding of it.

It is essential that LEPs recognise the importance of social enterprise and have it clearly included in their strategic priorities

We have completely rebuilt our website and continue to expand our free information service – now over 350 subscribers

We must ensure that the LEP's future investment priorities include business support that is appropriate for and reflects the values of social enterprise

Research, information and educational efforts to support the social enterprise sector and help aid public understanding of it will continue to be a priority

Impact

While difficult to quantify impact, we believe these activities have been of benefit to the wider social enterprise community in a number of ways:

- By raising the profile of social enterprise and improving public awareness and understanding;
- By creating opportunities for inter-trading;
- By helping to ensure that new and emerging policy (such as the Social Value Act) does create new market opportunities for social enterprise;
- By ensuring that social enterprise remains at the top of the policy agenda, including that of the Greater Birmingham & Solihull Local Enterprise Partnership;
- By helping to promote social enterprises' events – we have received numerous emails from enterprises whose events we have helped promote to say that not only did they manage to sell out and fill the event but they got a much better audience profile as a consequence of our support.

The impact of our work continues to be closely aligned with our original aim of offering strategic support and development to the social enterprise sector

Our activities remain closely aligned with our original aims of offering strategic support and development to the sector.

BSSEC and its members will continue to work together for the benefit of the social enterprise sector, focusing on growing the sector, making it more sustainable, and adding value wherever we can.
